## **SOTCH** State of the County Health Report


## What is the SOTCH?

- State report that is required for accreditation
- Every year that there isn't a community health needs assessment (CHNA), counties must submit a SOTCH
- The purpose of the SOTCH is to inform the state and the community about the progress that has been made since the CHNA

## **COMMUNITY HEALTH IMPROVEMENT PLAN PROGRESS**

## <u>Substance Use</u>

#### Medication Take-back

- Rowan County has 17 medication drop boxes distributed across the county.
- The drop boxes collected 192,641.7 pounds of medications in 2023.

#### 2023 Narcan Distribution and Training

- 1,520 boxes (with two doses per box for a total of 3,040 doses) of Narcan were distributed to community members.
- 102 boxes (204 total doses) of Narcan were provided to the Rowan County Detention Center to be available to individuals upon release.
- 29 trainings were provided to community organizations which resulted in 577 individuals being trained.

#### Safe Syringe Program

- The Rowan County Safe Syringe Program opened on December 12th, 2023.
- Post Overdose Response Team (PORT)
- 778 unique participants were served.

## <u>Healthy Lifestyles</u>

#### **Rowan Moves**

- Rowan Moves has continued to grow and collaborate with community partners to encourage physical activity.
  - 500 community members registered
  - 185,077,464 steps logged
  - 10 "Choose Your Own Adventure" events hosted by community partners
  - 2 Move with the Mayor Events

#### **Municipality Walking Maps**

 6 municipalities have worked with RCPH to identify safe walking paths in their townships and designed signs to assist community members be more active.

#### **CATCH My Breath**

• All middle schools received an anti-vaping curriculum to implement

#### Daily Mile

• 7 Elementary Schools in Rowan County are implementing the physical activity program

#### Mental Health Digital Marketing

- RCPH utilized multiple methods of marketing to disseminate messaging about 988
  - Salisbury Post
    - Total number of impressions: 51,911
    - Number of Clicks: 31
  - National CineMedia (NCM)
    - When the Taylor Swift movie was released in movie theaters, RCPH contracted with NCM to show messaging about 988 during their preshow advertisements
    - This campaign resulted in 68,327 impressions and 18 individuals visiting the 988 after viewing the ads

#### Into the Light Walk Sponsorship 988 marketing with Salisbury Fire and Police

 Collaboration with municipality first responders to advertise the National Crisis and Lifeline by placing bilingual 988 magnets on all fleets.

## **NEW & CONTINUING PROGRAMS**

### Harm Reduction Programs

<u>Services</u>

- Provide onsite syringe access and disposal with minimal environmental impact, ensuring safe disposal.
- Offer information and resources
- Provide referrals to vaccination, testing, primary care, addiction treatment, MAT, mental health support, food, housing, and other services.
- Supply wound care materials, Narcan, safer injection guidance, sharps containers, and Narcan administration training.
- Refer individuals to HIV/sexually transmitted infection (STI) and pregnancy prevention resources

In 2023:

- 1,520 boxes (3,040 doses) of Narcan were distributed to the community
- 1,278 total PORT contacts
   778 unique participants
- 910 Overdoses
  36 Overdose deaths
- Safe Syringe program opened on December 12th

## Mobile Dental Outreach

In October 2023, Rowan County Public Health was able to resume our school dental clinics which had been paused since 2020 due to the COVID-19 pandemic.

- October 16-20th: Morgan Elementary
  - Able to provide screenings and treatment to 39 students
  - Referrals were made for continued treatment in our RCPH Smile Center for students with follow-up needs.

The mobile dental clinic is scheduled to continue throughout 2024.

## Environmental Health Quality

Community Health Needs Assessment

- RCPH, in collaboration with Cabarrus Health Alliance (CHA), is developing a report that compares various environmental health indicators across Rowan and Cabarrus Counties.
- These indicators include
  - Number of children who have tested high levels of lead in their blood,
  - Private drinking water wells that may have elevated levels of harmful contaminants, and
  - Descriptions of programs and services within the Rowan and Cabarrus Environmental Health Departments.

### Qualitative Data Collection

- RCPH and CHA will be hosting two focus groups
  - Conversations will be focused on community-built environments, inside-thehome environmental factors, and outsidethe-home environmental factors.
- An environmental health and wellness survey will be distributed to community members to understand lived experiences.

## **EMERGING ISSUES**

## Vaccine Hesitancy

Since the COVID-19 pandemic, there has been an increase in vaccine hesitancy among both Americans and North Carolinians. Because of this, there has been a decrease in disease-preventable immunizations which has led to outbreaks across the nation (i.e. Measles).

In response to this emerging issue, RCPH will be focusing on combating misinformation, promoting child and adult immunizations, and educating community members about health department services, such as our immunization clinc.

## **Communicable Diseases**

#### Communicable Disease Outbreaks

• Throughout 2023, RCPH investigated and reported a total of 20 outbreaks. Most of them were in long-term care facilities, 19 were respiratory illnesses and 1 was gastrointestinal.

#### Sexually Transmitted Infections

- From January 1st-September 30th, there were 50 Congenital Syphilis cases in North Carolina, a decrease from 2022. However, in 2023 there were five stillbirths or neonatal deaths due to Congenital Syphilis.
- Since 2022, there has been a slight decrease in Chlamydia and Gonorrhea cases and a slight increase in Syphilis cases.
- In 2024, four new cases of HIV/AIDS were reported.

In response to this emerging issue, RCPH will be working with community partners to educate residents about STIs, communicable diseases, and the importance of seeking treatment with their primary care providers if symptoms of communicable diseases are noticed.

## Adolescent Substance Use

Rowan County Public Health and youth-serving organizations have not been able to collect current adolescent health data since before the beginning of the COVID-19 pandemic. However, through conversations with parents, teachers, principals, and other school system staff, substance use among teens has increased significantly. Primarily with the use of vapes and THC/CBD products.

In response to this emerging issue, RCPH will be working with community partners to collect data, as well as implement substance use prevention initiatives in the community.
